

### TUCSON SPEEDWAY MEMBERSHIP FORM

#### 2019 INEX Race Season

#### Legends and Bandoleros

**Track Membership:** All Legend and Bandolero drivers **MUST** be a current **INEX Member**. Membership is optional for others including: crew, family, etc. Annual membership covers Tucson Speedway's January – December 2019 race season. Memberships may be purchased from [www.uslegendcars.com/documents/](http://www.uslegendcars.com/documents/) and fees are listed on their forms. Drivers must hold a full permanent membership to be eligible for yearend awards.

**Race Night:** Pit Admission for members is **\$30.00**, non-members is **\$40.00** and kids 10 and under **\$10.00**. **NOTE: Drivers must purchase a pit pass for each class they race in each race night.**

**Car Numbers:** All car numbers must be registered for **\$25.00 per class, per season**. Duplicate numbers are not allowed in any class. The car owner/driver who reserved the number **and participated** last season has first choice to that number. If the number was not reserved **and ran** last season, the car finishing the highest in the **2018** points season will have first option to register the number. **Thereafter, the received date of the form will determine the number assignment.** Any **1, 2 or 3 digit** number is allowed.

**Pit Stalls:** Pit stalls will cost **\$125.00 each - No electricity is provided.** The person who reserved the stall **and participated** in the **2018** season will have first choice for that stall in the **2019** season. **For Special Events or when your division(s) is not scheduled to run, the stall may be used by other participants at any time.** You need to reserve your pit stall as soon as possible or it will be released and reassigned by January **25<sup>th</sup>, 2019**.

**Motorhome/Camp Trailer Parking:** An annual storage fee of **\$500.00** will be charged for leaving a Motorhome/Camp Trailer at the track for the season. **No electricity is provided.**

**NOTE:** All car owners or drivers (whomever is going to receive pay and year-end tax information) must complete and submit a W-9 form with the membership form to receive payout winnings. Each individual must complete a separate membership form.
